



## RULES AND CONDITIONS 2017 IDAHO CUP Futurity and Derby Stakes

1. All horses must be nominated in the IDAHO CUP stakes race program in order to participate in the IQHA IDAHO CUP Quarter Horse Stakes.
2. Stakes races are open only to Quarter Horses registered with the AQHA and *FOALED IN IDAHO*. All owners must be 2017 members of IQHA-Racing Division.
3. All races shall be conducted under rules of Idaho State Racing Commission and AQHA.
4. The decision of the Stewards shall be final in all matters. All fees and payments are accepted only on the condition that all persons nominating or starting a horse in this event agree to abide by the decision of the Stewards and/or the Idaho Racing Commission.
5. Each trial shall be raced under the same conditions as the Stakes with the fastest ten times going into the finals.
6. Entries in the trials owned by the same owner or trained by the same trainer shall be split if possible.
7. In the event of a timer malfunction, the stewards will revert to hand times to determine qualifiers.
8. Should a horse be disqualified in the trials, he shall be given the time of the horse he is placed behind plus .001 second.
9. Should the front gates fail to open in front of a horse during the running of the trials or stakes, the horse shall be declared a non-starter and no liability will be incurred beyond the return of all payments that have been paid on such horse.
10. Of the nomination and sustaining fees, 10% shall be deducted to defray expenses for the IDAHO CUP program; and 10% of the gross purse shall be deducted for Nominator Awards, to be distributed on the same basis as the purse distribution of each IDAHO CUP Stakes Race on all finals.
11. Purse distribution shall be (10) monies as follows: 40%, 20%, 10%, 8%, 6%, 5%, 4%, 3%, 2%, and 2%.
12. Nominating and sustaining payments must be made through the U.S. Mail or by Credit Card and must be received on or before the payment deadline listed.
13. IQHA and/or Sandy Downs reserves the right to cancel or postpone these Stakes races for any reason it deems good and sufficient; and IQHA agrees to return to the horsemen all nomination and/or sustaining fees that have been paid, less 10% for administrative expenses.
14. The signing this document, the undersigned confirms that he/she is familiar with the rules and regulations governing Quarter Horse Racing by Idaho State Racing Commission, IQHA and Sandy Downs; and such persons agrees to comply with the decisions of the Board of Stewards and/or Idaho State Racing Commission.
